I/We agree NOT to hold Lone Camp Baptist Church, its leaders, members, employees and volunteer staff liable for ANY damages, losses, diseases, or injuries incurred by the child of this form. I/We also agree not to seek any monetary or punitive retribution from Lone Camp Baptist Church, its employees, leaders, members and volunteer staff in the event of damage, loss, disease or injury occurs. This permission slip and release form supersedes any previous release form and will remain in effect and on file until the end of 2022. This form must be signed and returned to be placed on file for child to participate in any activity or event or to ride a vehicle provided by Lone Camp Baptist Church.

LONE CAMP BAPTIST CHURCH VEHICLE RULES

ALL VEHICLE RULES WILL BE STRICTLY ENFORCED AND MUST BE APPROVED BY PARENT PRIOR TO ANY CHILD RIDING IN A LONE CAMP BAPTIST CHURCH VEHICLE.

1. Lone Camp Baptist Church nor any driver for Lone Camp Baptist Church will be responsible for any child until they enter the church vehicle.
2. Lone Camp Baptist Church vehicle will arrive at pickup area at 5:20 p.m. on Wednesdays. Lone Camp Baptist Church vehicle will depart pickup area at 5:30 p.m. and return to Lone Camp Baptist Church. All passengers will remain seated at all times while in transit.
3. Disrespect of other passengers or drivers will NOT be tolerated period, end of discussion. First offense will be a verbal warning. Second offense will be loss of privilege to ride vehicle until a meeting between the driver, the child, and the child's guardian to discuss the problem. Third offense will result in losing the privilege to ride any Lone Camp Baptist Church vehicle.
4. Loss of personal items are not the responsibility of Lone Camp Baptist Church.
5. Lone Camp Baptist Church vehicle will return to drop off area around 7:45 p.m. Passengers will not be allowed off vehicle until parent/guardian is present to pick up child unless prior arrangements have been made. All children not picked up by 8:00 p.m. will be returned to Lone Camp Baptist Church, 108 Hoover Rd, Palo Pinto, Texas (Lone Camp) where parent/guardian may pick them up.

NOTE: This past year we had several incidents at the Santo pickup with children not being at the pickup area on time and were at the school grounds unattended from end of school until pickup time. We will not be responsible for any children between the end of school day until pickup time. One incident involved children being put into the bed of a pickup truck and taken to an undisclosed location. Parents be aware of where your children are at all times.

I have read and I understand Lone Camp Baptist Church Vehicle Rules and will explain all of the rules to my child. I also understand that there will be consequences for not following all the rules as listed above.
